#### ICAM CHARTERED ARBITRATOR ADMISSION

A person with <u>all the following</u> qualifications may act as Chartered Arbitrator with the ICAM Court:

- a) Having full civil legal capacity;
- b) Having a university qualification and at least five years work experience in the discipline which he/ she studied;
- c) In special cases an expert with highly specialized qualifications and considerable practical experience
- d) May still be selected to act as an arbitrator notwithstanding he/she fails to satisfy the requirements described in sub-clause (b) above.

Pursuant to the Charter of ICAM, person filing application for admission as a Chartred Arbitrator of the ICAM Court shall satisfy the conditions as follows:

#### 1. General conditions

- a) Age from 30 to 70;
- b) University-graduated and having experience to work in this field no less than 5 years, except for experts with high level of profession and experience;
- c) Committing to resolve the disputes independently, objective and fair; Ready to participate in the activities of the Centre; endeavor to contribute to the development of the Centre.
- d) May still be selected to act as an arbitrator notwithstanding he/she fails to satisfy the requirements described in sub-clause (b) above.

#### 2. Additional conditions

In addition to the conditions provided in paragraph 1 above, person filing application for admission for Chartered Arbitrator shall satisfy one of the conditions as follows:

- a) Having been arbitrator in the three previous disputes resolved by arbitration, or
- b) Being in List of Arbitrator of a worldwide-accepted arbitration organization and has resolved at least one dispute in this organization, **or**
- c) Introduced by the professional society in nationwide level, or university or academy, or
- a) Introduced by at least one of members of the Executive Committee;

The satisfaction of the applying person of those conditions does not guarantee that such person shall be admitted as Chartred Arbitrator by ICAM. The consideration of the admission of a person as Chartred Arbitrator of ICAM falls within the authority of the Executive Committee of the ICAM Court.

#### Cannot become an ICAM member:

A person under a criminal charge or prosecution or who is serving a criminal sentence or who has fully served the sentence but whose criminal record has bit yet been cleared.

### **Application Information**

The ICAM Panel is composed of specialists in international dispute resolution from around the world. Openings on our Panel are extremely limited and are based primarily on caseload needs, national diversity, and user preferences. Consequently, even candidates with strong credentials may not be added to our Panel. Both internal (ICAM Executive Staff) and external review committees screen candidates for their case management skills, substantive expertise, commitment, ethics, training, and suitability to the caseload. Panel members are required to have achieved academic and professional honors that mark them as leaders in their respective fields.

#### Qualifications

Applicants for membership on the ICAM Panel of Chartered Arbitrators and Mediators must meet or exceed the ICAM's requirements.

- e. Membership in a professional association(s), if any;
- f. Other relevant experience or accomplishments (e.g., published articles)
- g. May still be selected to act as an arbitrator notwithstanding he/she fails to satisfy the requirements described in sub-clauses above.

#### **Neutrality**

- a. Freedom from bias and prejudice
- **b.** Ability to evaluate and apply legal, business, or trade principles

#### **Judicial Capacity**

- a. Ability to manage the hearing process
- **b.** Thorough and impartial evaluation of testimony and other evidence

#### Reputation

- a. Held in the highest regard by peers for integrity, fairness, and good judgment
- **b.** Dedicated to upholding the ICAM Code of Ethics for Chartered Arbitrators and/or Standards of the Code of Conduct for Mediators

#### **Commitment to ADR Process**

- a. Willingness to devote time and effort when selected to serve
- b. Willingness to participate in continuing education programs pursuant to ICAM Guidelines

#### **Personal Letter**

Submit a letter explaining why you should be admitted to the ICAM International Panel of Chartered Arbitrators and Mediators. Please note that as a general rule only experienced international Chartered Arbitrators and mediators will be considered. Your letter should also acknowledge your willingness to commit yourself to serving the needs of disputants, as well as a further commitment to attend the "best practices" seminars which form the cornerstone of the ICAM's international administrative system.
